PARK ORDINANCE AND GENERAL PARK RULES

ORDINANCE NO. 11-2-09 REVISED 01-15-14

BE IT ORDAINED BY THE SUPERVISOR AND BOARD OF TRUSTEES OF FREMONT TOWNSHIP, LAKE COUNTY, ILLINOIS

Fremont Township hereby adopts the Illinois Criminal Code Chapters 705 and 720 Illinois Criminal Law and Procedure, as from time to time amended, as the rules governing criminal offenses on Township property, except where Township ordinances specifically establish different rules. Enforcement shall be authorized by any law endorsement officer or authorized agent.

SECTION 1.0 - PARK OPERATION:

Except for unusual and unforeseen emergencies, the opening and closing hours shall be posted therein for the public information. Hours for general park use shall be from daybreak until sunset unless otherwise posted.

Any section or part of any park including ponds may be declared closed to the public by the Township Board at any time and for any intervals (daily or otherwise) and either entirely or merely to certain uses as the Township Board shall find necessary.

The finding of lost articles shall be turned in, or reported, to the Township office at 22385 W. Illinois Route 60, Mundelein, IL 60060.

The Township Board or their designee may require the permittee to hire an off-duty police officer or registered and licensed security company to patrol the assigned area during any scheduled event of any such permittee and/or sport organization(s).

The Township Board shall have the authority to revoke a permit upon a finding of violation of any rule governing the use of Fremont Township Park property or ordinances, or upon good cause shown.

SECTION 2.0 - PARK PROPERTY

NO PERSON SHALL:

Willfully deface, disfigure, tamper with, displace or remove, any building, bridges, tables, benches, fireplaces, paving or paving materials, water lines or other public utilities or parts of appurtenances thereof, signs, notices or placards, netting of any kind, whether temporary or permanent equipment, facilities on the park property or appurtenances whatsoever.

Fail to cooperate in maintaining restrooms in a neat sanitary condition.

Dig or remove, whether submerged or not, or any soil, rock, stones, trees, scrubs, or plants, downed timber, or make any excavation by tool and/or equipment, blasting or other means.

Construct or erect any building or structure of whatever kind, whether permanent or temporary, run or sting any public utility into, upon or across Township properties, except when special written approval by the Township Board and with permit issued.

Damage, cut, carve, transplant or remove any tree or planting of any kind or injure the bark, or pick the flowers or seeds of any trees and plant.

Climb, stand, sit or walk on any Township property not designated or intended for such use.

Place, stockpile or store any gravel, stone, dirt, sand, wood of any kind or any other materials on Township property.

Release any animal, or bring in, plant, cultivate, harvest, or distribute the seeds or spores of, any plant.

Fish, release any type of fish, and dump any liquids into the pond or boat.

SECTION 3.0 - BEHAVIOR:

NO PERSON SHALL:

Build or attempt to build a fire except in such areas and such regulations as designated by the Township Board. No person shall drop, throw or otherwise scatter lighted matches, fireworks, burning cigarettes, or cigars, tobacco of any kind, paper or other flammable material within any park area or on any highway, road or street abutting or contiguous thereunto.

Enter an area posted, "Closed to the Public" no shall any person use or abet the use of any area in violation of the posted notices.

Without authority in writing, gamble or participate in or abet any game of chance.

Go out into the ice of any of the waters.

No one is permitted to film or photograph a minor child without the expressed permission of the parents and/or legal guardians.

SECTION 4.0 - DISORDERLY CONDUCT:

A person shall be deemed to have engaged in disorderly conduct when he/she knowingly:

- 1. Does any act in such unreasonable manner as to provoke, make or aid in a making a breach of peace.
- 2. Does or makes any offensive act, utterance gesture or display, which, under the circumstances creates a clear and present danger and/or imminent threat of violence.
- 3. Refuses or fails to cease in any conduct or activity that is likely to produce a breach of peace and where there is imminent threat of violence.
- 4. Where the police or authorized security company have requested that said conduct and activity be stopped.
- 5. Uses coarse or profane language of any kind.

SECTION 5.0 - PUBLIC INDECENCY:

NO PERSON SHALL:

Engage in conduct that is publicly indecent, and a person(s) is deemed to have committed an act of public indecency when, any person(s) perform any of the following acts:

- 1. An act of sexual intercourse.
- 2. An act of deviate sexual conduct.
- 3. A lewd exposure of the body done with intent to arouse or to satisfy the sexual desire of the person.
- 4. A lewd fondling or caress of self or the body of another person of either sex.

SECTION 6.0 - OBSCENE BOOKS and PAMPHLETS:

NO PERSON SHALL:

Knowingly exhibit, sell, give away, and offer to sell or give away on Township property any obscene book, pamphlet, paper, drawing, movie film, picture, photograph, or any other article of any kind of an obscene nature.

SECTION 7.0 - OBSCTRUCTIONS:

NO PERSON SHALL:

Set, place or cause to be set and/or placed any goods, wares or merchandise on any stand, cart or vehicle for the vending of such

upon any property of the Township causing an obstruction of use of Township property.

By force, threat, intimidation, unlawful fencing, enclosing or any other unlawful means prevent, obstruct or combine with others to prevent or obstruct any person from peacefully entering upon Township property or to obstruct the entrance in any building or structure. Nothing in this section shall be construed to deny, enforcement of a valid permit granting a certain person or persons use to the exclusion of others as defined and provided for in this ordinance.

SECTION 8.0 - Construction and MAINTENANCE:

NO PERSON SHALL:

Erect, construct, install, or perform any maintenance on, below, over or across Township property except by proper authorization of the Township with permits as may be needed.

SECTION 9.0 - FACILITIES RETRICTED for USE BY SEX:

NO PERSON SHALL:

Enter into or remain in any toilet, restroom, pavilion or structure or section thereof, which has been reserved and designated for use of the opposite sex (with the exception made for children under the age of five (5) years accompanied by a legal guardian). Nor shall any person loiter in or around any restroom or dressing room for soliciting another to engage-in sexual behavior. This section shall not prohibit a person of the opposite sex from assisting a disabled person's use of the restroom facilities, and/or in the performance of cleaning and maintenance.

SECTION 10.0 - SANITATION:

NO PERSON SHALL:

Throw, discharge, place or cause to be placed in the waters of any fountain, pond, lake, stream, storm water, or drain flowing into such waters, any substance, matter or thing; liquid or solid, which would or may result in the pollution of said waters.

Refuse and Trash: dump, deposit or leave any bottles, broken glass, ashes, paper, boxes, cans, dirt, rubbish, waste garbage, or other trash. All refuse shall be placed in the proper receptacles. Where

receptacles are not provided, all such rubbish or waste shall be carried away from the park by the person responsible for its presence, and properly disposed of offsite.

SECTION 11.0 - SMOKING:

Fremont Township is a smoke-free campus.

SECTION 12.0 - DRUG or ALCOHOL:

NO PERSON SHALL:

Possess, give away, sell, serve, dispense or drink any alcoholic beverage, or possess, sell, deliver, smoke, inhale, inject, eat, chew or swallow any beer, wine, or other alcoholic beverage, narcotic drug, or controlled substance, upon any Township property. Any person found to be in violation of this section shall be subject to arrest or ejected from the Township premise.

SECTION 13.0 - CONTROL and TREATMENT of DOMESTIC ANIMALS:

All animals must be leached at all times when on Township property. Nothing in this ordinance is to be construed as to prohibit the use of certain approved animals for purposes of controlled use such as, service dogs, for public safety, the protection of the Township property, the protection of employees, or in the performance of duties of search and rescue.

SECTION 14.0 - VENDING and ADVERTISING:

NO PERSON SHALL:

Offer for sale or hire any article or thing, conduct or solicit any business, trade, occupation or professional without the approval of the Township and then only in accordance with terms and conditions prescribed by the Township in control of commercial enterprises or sales on Township lands are not allowed.

Display, distribute, post or fix any placard, sign, handbill, pamphlet, circular, or any other writing or printed material or objects containing advertising matter or announcements of any kind whatsoever without permission from the Township. Groups holding a valid picnic/facility rental permit or special use permit may display signs to identify their location or direct others to it, providing such signs are

temporary and removed by permittee at the termination of the activity.

Solicit contribution in any manner upon the Township facility, except as authorized by the Township Board and associates with the permittee user.

SECTION 15.0 - WEAPONS and HARMFUL SUBSTANCES:

Fremont Township is a weapon free campus.

NO PERSON SHALL:

At any time have their possession or on or about their person any firearm, pistol, revolver, rifle, shotgun, ammunition of any kind, bow and any arrows, crossbow, slingshot, blackjack, billy-club, or any device capable of discharging a projectile by air, spirit, gas or explosives, or any explosive substance or harmful solid, liquid or gaseous substance any tear gas or disabling chemical agent or other dangerous weapons. Nothing herein is to be construed as to prevent any police officer or licensed security company as may be authorized and necessary in the discharge of their duties. Nor shall it apply to any person summoned by any such officer to assist in making arrests or preserving the peace while such person is engaged in assisting.

Bring into Township property any-trapping devise, any incendiary bomb or other materials, any smoke or stink bomb, any acid or caustic substance or any inflammable liquid, except charcoal lighter or fuel contained in the fuel tank of a motor vehicle. Discharge any weapons or instruments into or over Township property.

SECTION 16.0 - PYROTECHNICS:

NO PERSON SHALL:

Possess, set off, attempt to set off or ignite any firecrackers, fireworks, smoke bombs, rockets, black powder, guns or other pyrotechnics without written approval, and then only under such rules and regulations as may be promulgated by the Township and subject to all local, state, and federal laws.

SECTION 17.0 - TRAFFIC:

NO PERSON SHALL:

Fail to comply with all applicable provisions of Illinois State and Lake County Motor Vehicle Traffic Rules and Regulations.

Fail to comply with laws with regard to equipment and operation of vehicles together with such regulations.

Fail to obey all traffic officers', security personnel and park employees authorized and instructed to direct traffic.

Fail to observe all traffic signs indicating speed, direction, caution, stopping, parking, crosswalk lanes, traffic lane markers, and all other signs posted by the Township, for proper control for safeguarding life and property.

Drive any vehicle on any area except the paved parks roads or parking areas. Alternatively, on such other areas as might on occasion be specifically, designated traffic, except any one way driveway-such limitations shall be 10 feet.

Double park any vehicle on any driveway unless directed by a park official or temporarily for discharging passengers.

Leave a vehicle standing or parked at night without lights clearly visible for at least 200 feet from both front and rear on any driveway or road area except legally established parking areas.

No parking on any driveway or in any free parking area between sunset and dawn of any day.

Leave any vehicle anywhere in the park more than 24 hours without Township approval. At the end of this period, the vehicle will be towed away at the owner's expense.

Owner or operator must be on premises with vehicle. Vehicle is subject to towing if left unattended on Township property.

No riding upon fenders and/or any other outside part of any vehicle parked or moving.

Change any parts or make repairs of any vehicle on Township property, except such emergency repairs necessary to remove such vehicle from the property.

Change oil or grease, wash or polish vehicles and leave debris from such action.

SECTION 18.0 - REGULATION of the USE OF "OTHER MOTORIZED VEHICLES":

It shall be unlawful for any person to operate a snowmobile, minibike, and dirt-bike, two or four wheel drive carts or off the road type vehicles on Township property.

SECTION 19.0 - REGULATION of the USE of BICYLES:

Individuals must operate bicycles in accordance with current state regulations in the Illinois Bicycle Rules of the Road Booklet.

No person shall ride any bicycle on any area except the paved park roads, parking areas or such other areas as specified.

All unattended bicycles shall be placed in the bicycle rack when such is provided and there is space available.

SECTION 20.0 - RECREATIONAL ACTIVITIES:

NO PERSON SHALL:

Picnic, participate in or to take part of activities, abet the playing of games involving thrown or otherwise propelled objects such as balls, model airplanes, remote control air planes, boats, or helicopters etc. except in areas or facilities set apart for such forms of recreation and under rules and regulations as designated.

Hunt, trap or pursue wild life at any time.

It is forbidden to shoot into park areas from beyond the park boundaries.

Misuse of Play-lot equipment is grounds for immediate ejection.

Skateboards, skates: In-line skates and roller blades shall not be allowed in any parking lots and roadways, use on sidewalks, basketball courts, ramps, railings or benches.

SECTION 21.0 - ENFORCEMENT:

The Board of Trustees, its designees shall in connection with their duties imposed by law, diligently enforce the provisions of this Ordinance.

The Board of Trustees, its designees, police, any law enforcement office or authorized security personnel shall have the authority to eject from the park any person acting in violation of this Ordinance.

The Board of Trustees, its designees, police, any law enforcement officer or authorized security personnel shall have the authority to require a showing of proof of identification (i.e. voters registration card, selective service registration, driver's license, etc.) of any person using the park.

The Board of Trustees, its designees, police any law enforcement officer or authorized security personnel shall have the authority to seize and confiscate any property, thing, or device in or used in the parks in violation of this Ordinance.

SECTION 22.0 - HINDERING OR BRIBERY:

NO PERSON SHALL:

Interfere with unreasonably disrupt, delay or in any manner hinder any Township employee or distract him/her from the performance of their duties.

Give or offer to give an employee any money, gift, privilege, or article of value on or off Township property in order to violate the provisions of this ordinance or any other Township ordinance, contract, or permit or a statute of the State of Illinois and the United States or in order to gain or receive special consideration in applying for any use or privilege or to gain special consideration and treatment in the use of any portion of the Township property or facility.

Fail to obey a lawful order of dispersal by Township personnel, police officer, or security personnel under circumstances where a person are committing acts of disorderly conduct or acts that are likely to cause substantial harm or serious inconvenience, annoyance or alarm.

SECTION 23.0- BANNED:

Any person found violating the provisions of this ordinance may be immediately expelled. Upon recommendation of the Township Board, the Township and/or the Supervisor may ban an individual, individuals or any group from Township property for a period not to exceed thirty (30) days. Upon a majority vote of the Township Board, an individual, individuals or group found violating this ordinance maybe denied access to Township property for a period in

excess of thirty (30) days. A notice banning an individual, individuals or a group from Township property shall be sent written notice to their last known address via certified mail with signature return.

SECTION 24.0 - TRESPASS:

Any person found entering upon Fremont Township property after receiving notice banning them from Township property shall be subject to arrest and prosecution for criminal trespass to land unless such party has a valid appointment with a Township official or employee of services.

SECTION 25.0 - PENALTY:

Any party violating the provision of this ordinance is subject to a minimum of One Hundred Dollar (\$100.00) fine to a maximum of Seven Hundred Fifty Dollar (\$750.00) per violation. In addition, any party damaging Township property shall be required to pay restitution to the Township for the repairs and/or replacement for the damages, additionally all court cost and legal fees incurred are subject to reimbursement.

SECTION 26.0 - EFFECTIVE DATE:

This ordinance shall be in full force and effect from after its passage and published in a pamphlet for in a manner provided by law.

SECTION 27.0 - SEVERABILITY:

In the event that any section, clause provision or part of this ordinance shall be found and determined invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force.
