OLD BUSINESS

IEMA Citizen Corps requested assistance from CERT trained and licensed snowmobilers to aid stranded motorists in our area. Three Fremont CERT Team members were able to help. A CERT Team call-out was initiated to assist with the shelters at the Hindu Temple and Fremont Township. Our Township staff and CERT received thanks from the Lake County EOC for stepping up to the plate during this emergency.

22438 W. Erhart Road, Mundelein IL 60060

An e-mail was received from Township Attorney, Frederick Rawles, regarding said property and the Easement Agreement created April 13, 1971. In this communication it was proposed that Robert Tekampe would consider eliminating the easement in return for a land swap with the Township. The easement would be eliminated in return for the Township conveying enough property along the

Township's western boundary and around the garage necessary to eliminate the garage encroachment and also conform to Lake County side yard setback requirements.

Supervisor Tekampe received an opinion from TOI saying that because he has no pecuniary
interests to said property, he does not need to censure himself from the discussion concerning it.
With this in mind, he is suggesting that an outside attorney give an opinion regarding the 'Grantor'
issue with regards to Special Warranty Deed No. 364603.

Trustee Martin – The Board has been dealing with issues at 22438 W. Erhart Road for approximately 10 months with no clear resolution. At this time he is presenting a series of motions to the Board:

- Martin moved that any and all debate from each speaker for each of the following motions be limited to a comment and limited to a period of two minutes with no interruptions. Motion failed for lack of a second.
- 2. Martin moved and Shanahan seconded the motion to rescind all considerations from the motion October 10, 2010 approved by the Board for the consideration of bidding and erection of any fence "along west property line between the Township property and the adjacent home (Tekampe)" with no future action to be taken by the Township. To be clear, this motion states that the township will not be erecting any fencing along the boundary between the properties. All in favor, motion carried.
- 3. Martin moved to send a letter addressed to Mr. Robert Tekampe agreeing he has the rights to erect any fence on the western property line between the two properties conforming to Lake County codes, permit requirements and that any fence erected on the Tekampe property comply to code setbacks and by not allowing any fencing erection using and/or on any portion of the easement property. Motion failed for lack of a second.
- 4. Martin moved and Gustafson seconded the motion to rescind the motion of October 11, 2010 approved by the Board "to move the berm between the Township property and the Robert Tekampe property so that it is completely located on the Township property" with no further action to be taken by the Township. There is a letter on file with Lake County Building and Zoning dated December 4, 1996, signed by Robert Tekampe giving permission for the toe of the berm to be on the property line. Mr. Robert Tekampe needs to rescind this letter before the Township does anything and then we can revisit this issue. All in favor, motion carried.
- 5. Martin moved and Shanahan seconded the motion to rescind the motion of November 1, 2010 approved by the Board "authorizing Mr. Fred Rawles, Township Attorney, to correct Special Warranty Deed No. 364603 and re-execute a new agreement making Fremont Township the Grantor and to accurately describe the purposes for the easement." And notify Mr. Rawles to suspend all legal work connected to this motion, easement of property and submit a final invoice for the work completed as of this date. There was no discussion. All in favor, motion carried.
- 6. Martin moved and Shanahan seconded the motion that Fremont Township interview for legal advice and representation for Fremont Township; interviewing a minimum of three (3) attorney firms familiar with Illinois Township requirements, needs and an association with TOI and; (i) the selected firm is approved prior to the annual meeting; (ii) the requirements of Fremont Township are attending the annual town meeting; and (iii) responding to the Board's requests and inquiry in a reasonable time. Frederick Rawles would have the opportunity to interview. His status as Township attorney does not change until a new attorney is appointed. All in favor, motion carried.
- 7. Martin moved and Shanahan seconded the motion to send a letter to Mr. Robert Tekampe and his attorney advising receipt of the e-mail dated January 1, 2011 from Mr. Peter LoMonaco, the attorney of Mr. Robert Tekampe, addressed to Mr. Fred Rawles asking for consideration from the Township to convey Township property to surrender "his" (Tekampe) easement in lieu of executing a new Grantor's document as previously requested by the Township is denied for consideration and with no further action. In essence we are not interested in a land swap. All in favor, motion carried.
- 8. Martin moved and Shanahan seconded the motion that at the time of hiring a new legal firm by the Township, the firm is charges with executing and correcting the Special Warranty Deed No. 364603 with any other documents referring to the "Grantor"; and taking any measure needed to complete Special Warranty Deed No. 364603 to list Fremont Township of Lake County, State of Illinois as the legal "Grantor" and record said document. This is the tax payers' easement, not Robert Tekampe's. After some thought, Gustafson amended the motion and Shanahan seconded the amendment to include and taking any measure 'agreed to by the Board' needed to complete Special Warranty Deed No. 364603 ... All in favor of the amendment, amendment carried. All in favor of the original motion with the amendment, motion carried.

Rose Marie Domeny - Questioned the status of the meeting with local fire commissioners on reverse 911with Fremont Township. Supervisor Tekampe responded, because of the construction of the new Grayslake fire station on Peterson Road, the meeting was delayed; it will be scheduled. The meeting will included fire districts as well as municipalities.

MINUTES

Gustafson moved and Shanahan seconded the motion to approve the minutes of the February 7, 2011 meeting of the Fremont Township Board of Trustees as presented. There was no discussion. All in favor, motion carried.

COMMITTEE REPORTS

Well and Water - Connie Shanahan - The public out-reach forum at the Fremont Public Library is Saturday, April 9 from 9 am to 2 pm.

Parks - Nick Tonkery - Next meeting is April 11, 2011 at 6 pm. Pictures were shown of a reinforced canvas structure that would be appropriate for the proposed artificial ice arena. Attendance at the Parks Committee meetings by the groups using the fields has been sporadic.

CERT - Chris McCann - CERT's quarterly meeting will be Monday, April 18. Four volunteers signed-up for the spring training class. Because it is difficult to run an effective program with four people, these recruits may receive their training with the Mundelein CERT group. The paper work has been completed for FEMA grant funding. A combined drill with CERT groups from Mundelein, Libertyville, Fremont and possibly Round Lake will occur in May.

22438 W. Erhart Road

Peter F. LoMonaco, PC, attorney representing Robert Tekampe, submitted invoices to Frederick Rawles, Township attorney, requesting that the Fremont Township Board reimburse Robert Tekampe a total of \$1,021.51 for expenses incurred in connection with the removal of the berm from his property; Mark Meade Excavating, Inc. \$560.00, Conserv FS \$61.52, legal fees \$400.00. Discussion:

Trustee Martin - By moving the berm, Robert Tekampe created a liability problem. Is there an insurance certificate on file naming Fremont Township hold harmless?

Martin moved to not consider payment for any expenses submitted by Robert Tekampe to remove the berm. These expenses were incurred by Robert Tekampe and not authorized by the Township for work completed.

Trustee Shanahan – We do not need a motion; we can disregard the communication from the

Trustee McCann - It would be irresponsible to pay for work that was not authorized; we would not be representing the people of Fremont Township very well. This would set a precedent that could open up the flood gates; residents could have work done on their property and submit invoices to the Township for payment.

Trustee Martin - According to the Easement Agreement # 1498610, the easement "is granted and it is accepted by the Grantees upon the expressed condition that the Grantees will indemnify and hold harmless the Grantor, its heirs and assigns, of and from any and all loss. costs, damages and expenses claimed or asserted against them or either of them or suffered

or incurred by them or either of them or claimed against or resulting to said above described strip of land by the use of said land by the Grantees." Do we have an insurance certificate on file holding Fremont Township harmless?

Trustee Martin - withdraws his motion.

Supervisor Tekampe feels the entire situation is getting out of hand and would like it to come to a resolution. On October 11, 2010 the Board passed a motion to move the berm between the properties so that it would be located completely on Township property.

Trustee Martin - This motion was rescinded at the February 2011 meeting and "no further action was to be taken by the Township" was included in this motion as well.

Trustee Shanahan - We were never approached for authorization to move the berm, we did not receive an estimate of expenses and we never authorized the removal; we should move on and inform Robert Tekampe that we will not reimburse his expenses.

Shanahan moved and Martin seconded the motion instructing Frederick Rawles to inform Peter F. LoMonaco that Fremont Township will not be reimbursing the property owner at 22438 W. Erhart Road, Mundelein IL 60060 for the invoices submitted for removal of the berm from his property. All in favor, motion carried.

NEW BUSINESS

Township Attorney

Trustee McCann questioned the status of having Fremont Township reinstated as Grantor on the Easement Agreement with Robert and Elizabeth Tekampe.

Supervisor Tekampe contacted Peter S. Karlovics, from the Law Offices of Rudolph F. Magna, for a legal opinion regarding two purported grants of easement upon Township property located at 22376 W. Erhart Road, Mundelein, IL. He further directed Supervisor Tekampe to the Illinois Compiled Statutes that state "the supervisor, with the advice and consent of the township board, may appoint a township attorney; the supervisor hires and fires the attorney. Therefore, the motion made at the February 7, 2011 Board meeting directing the Supervisor to interview for legal advice and representation was out of order.

Attorney Opinion: There are two basic types of easements, easements in gross (does not automatically transfer to future owners of the property served by the easement) and easements appurtenant run with the land). The first easement regarding use of the septic system located on Fremont Township property for 99 years demonstrates intent to allow the easement to run with the land for a period of 99 years. The second easement is less clear. The ambiguities can be resolved by looking at the intent and circumstances. Given that the Township allowed the construction of the gravel driveway and the garage building on the easement property, and the Township never demanded removal after the original owner conveyed the property to another owner, it appears clear that the Township intended for the easement to run with the land. However, Fremont Township's action in granting the easements is questionable. According to Township Code, the electors at an annual or special township meeting are granted the specific powers to make all orders for the purchase, sale, conveyance, regulation or use of the township's corporate property. If there was a defect in the granting of the two easements, due to lack of voter action, the 22438 W. Erhart Road property would still have an easement by prescription over the used portion of the Fremont Township property.

Trustee Martin suggests that in the future all opinions be given in writing not verbally to Supervisor Tekampe. He recommends that an amended or a new easement agreement be created accurately clarifying the gravel driveway.

Trustee McCann spoke to the fact that it was never the Township's intention to do away with the easement; the only action taken was to have Fremont Township named as the Grantor. would be beneficial to the Township and demonstrate to our residents due diligence if Mr. Karlovic would state in writing that having Fremont Township named as Grantor is not essential.

Attorney

Since the Supervisor appoints and terminates the attorney; Fred Rawles is representing Fremont Township. Trustee McCann continues to have concerns regarding the Township Attorney; the opinion received from Mr. Karlovics was more detailed and he informed us of pertinent information that was never before mentioned. The supervisor appoints the attorney and takes responsibility for the attorney's performance; the attorney represents the entire Board and the onus will be on the Supervisor if that information is incomplete. Trustee Martin concurs.

ANNUALTOWN MEETING

Gustafson moved and McCann seconded the motion to adopt the 2011 Annual Town Meeting Agenda as presented. There were no agenda items requested by Fremont Township electors. All in favor, motion carried. It was agreed that the Guidelines for the 2011 Annual Town Meeting would be posted.



Discussion:

- Trustee Shanahan thought that including different deductible levels in the bids would hamstring the Supervisor. The sentence with the deductibles should be removed from the motion. The Board can study quotes provided by the agents.
- Trustee McCann suggested replacing the verbiage regarding deductible levels with various/varying deductible levels.
- In Trustee Martin's judgment the various deductible levels need to be identified so that
 comparisons could be made between plans. The amount of yearly expense for health
 insurance premiums the Township expends is unrealistic; he will not initial another health
 care invoice until this situation is rectified.

2011 Levy Adoption

Road - Gustafson moved and Martin seconded the motion to adopt the Tax Levy Ordinance - Road District - No. 241-A in the amount of \$1,488,535. This represents a 1.49% increase over last year's extension in the Road District. Highway Commissioner Grinnell explained that because the assessed evaluation of the Township is not currently a firm amount, the tax rate cannot be exactly determined; it is estimated at .1375. This represents approximately \$21,998 more than last year's extension. All in favor, motion carried. Town – Martin moved and Gustafson seconded the motion to adopt the Tax Levy Ordinance – Fremont Township – No. 240—A in the amount of \$1,277,143. This is a 3.7%

decrease over last year's tax extension. If the tax rate remained constant at .113, the Township would receive \$102,723 less than the 2010 extension. By raising the tax rate .005, the Township will receive \$48,607 less than last year. This is the first time since Supervisor Tekampe was elected in 1993 that he is recommending a tax rate increase. Trustee Martin and Shanahan agree that the small increase in the tax rate is necessary. Trustee McCann asked where the Township planned to cut expenditures. She was uncomfortable raising the tax rate without looking at the Township's outflow of dollars. Because of the Truth and Taxation Act, extensions for any given year cannot exceed the CPI or 5%, whichever is lower without a public hearing. Because of this, severely lowering the extension can be dangerous to the future well-being of the Township. **Motion carried – 3 Ayes - 1 Nay (McCann) 0 Absent.**

2012 Schedule of Township Board Meetings

McCann moved and Martin seconded the motion to adopt the 2012 Schedule of Monthly Board Meeting as presented. All meetings are the second Monday of the month, except for January and November. All in favor, motion carried.

Transfer

Martin moved and Gustafson seconded the motion adopting the transfer of appropriation in the Road & Bridge Road Fund whereby \$370.00 is transferred from the unexpended balance of the line item General Insurance and added to the line item Drug Testing in the same fund. There was no discussion. All in favor, motion carried.

TOIRMA

TOIRMA is updating the building values for the township and road.
