TAX LEVY ORDINANCE

FREMONT TOWNSHIP

ORDINANCE No. 266

An ordinance levying taxes for all town purposes for **Fremont Township**, Lake County, Illinois, for the tax year 2017, collectable in 2018.

BE IT ORDAINED by the Board of Trustees of Fremont Township, Lake County, Illinois as follows:

SECTION 1: That the sum of **One Million One Hundred Ninety Eight Thousand Three Hundred Twenty Dollars (\$1,198,320.00)** are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

for the year 2017.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 5: That this Ordinance shall be in full force and effect after its adoption, as provided by law.


