ORDINANCE No. 267

An ordinance levying taxes for all road purposes for **Fremont Township Road District**, Lake County, Illinois, for the tax year 2017, collectable in 2018.

BE IT ORDAINED by the Board of Trustees of Fremont Township, Lake County, Illinois as follows:

SECTION 1: That the Highway Commissioner of Fremont Township Road District on December 11, 2017 does hereby determine and declare that the sum of **One Million Five Hundred Sixty Thousand Fifty Nine Dollars** (\$1,560,059.00) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Fremont Township Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

for the year 2017.
