ORDINANCE NO. 6-11-18

AN ORDINANCE ESTABLISHING A POLICY FOR CUTTING WEEDS AND SIMILAR NUISANCES AND FOR LIENING THE COSTS OF SAME

WHEREAS, Fremont Township (hereinafter, the "Township"), Lake County, Illinois, is a township operating under and pursuant to the Illinois Township Code; and

WHEREAS, the Township Code, 60 ILCS 1/105-15, provides that the Township Board may provide for the cutting of weeds or grass, the trimming of trees or bushes, the removal of nuisance bushes or trees, or the maintenance of a retention pond or detention pond on any real estate in residential areas in the Township no sooner than 7 days after notifying the owner or the appropriate property owners association by mail of the intent to abate the nuisance; and

WHEREAS, the Township Board desires to declare certain standards and nuisances regarding the cutting of weeds or grass, the trimming of trees or bushes, the removal of nuisance bushes or trees, or the maintenance of a retention pond or detention pond on any real estate in residential areas in the Township; and

WHEREAS, the Township desires to utilize the provisions of Section 105-15 to lien the costs associated with abating the above-referenced nuisances.

NOW THEREORE, BE IT ORDAINED BY THE SUPERVISOR AND BOARD OF TRUSTEES OF FREMONT TOWNSHIP, LAKE COUNTY, ILLINOIS AS FOLLOWS:

- **Section 1.** Recitals. That the above recitals are hereby incorporated into the body of this Ordinance and restated as though set forth herein.
- Section 2. Responsibility to Maintain. All property owners within Fremont Township shall have the duty to cut the weeds or grass on their property, keep trees and bushes trimmed and to remove nuisance bushes or trees all as set forth pursuant to the standards established in this Ordinance. In addition, any property owner of a retention or detention pond in the residential areas of the Township must keep such maintained pursuant to reasonable engineering standards.
- Section 3. Standards for Weeds, Grass, Bushes and Trees. No person shall permit any weeds, grass, or plants other than trees, bushes, flowers, or other ornamental plants to grow to a height exceeding eight inches anywhere in the Township. Any plants or weeds exceeding eight inches are declared to be a nuisance. Any weeds such as jimson, burdock, ragweed, thistle, cocklebur, or other weeds of a like kind found growing in any lot or tract of land in the Township are declared to be a nuisance. It shall be unlawful to permit such weeds to grow or remain on any place. Any tree or shrub which overhangs any sidewalk, street, or other public place in the Township in a way which impedes or interferes with traffic or travel shall be trimmed by the owner of the abutting premises or of the premises on which the tree or shrub grows so that the obstruction shall

cease. Any tree or limb of a tree which is likely to fall on or across any public place or way shall be removed by the owner of the premises on which the tree grows or stands and shall be declared a nuisance.

- **Section 4.** <u>Authority to Abate</u>. Any real property that is in violation of Section 2 or 3 of this Ordinance may be abated by the Township. In such situations, the Township must send a notice to the property owner in the form attached hereto as Exhibit A. Said notice must inform the property owner that the Township will abate the nuisance if such is not abated by the property owner within seven (7) days. If the property owner does not abate the violation, the Township may abate the violation and file a lien for the reasonable costs thereof.
- **Section 5.** Severability. In the event a court of competent jurisdiction finds this ordinance or any provision hereof to be invalid or unenforceable as applied, such finding shall not affect the validity of the remaining provisions of this Ordinance and the application thereof to the greatest extent permitted by law.
- **Section 6.** Repeal and Savings Clause. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions, or causes of action which shall have accrued to Fremont Township prior to the effective date of this ordinance.
- **Section 7.** <u>Effectiveness</u>. This Ordinance shall become effective immediately upon its passage and approval as required by law.

2018 TOWN PREVAILING WAGE ORDINANCE NO. 270

WHEREAS, the State of Illinois has enacted "An Act regulating wages of laborers, mechanics and other workers employed in any public works by the State, county, city or any public body or any political subdivision or by any one under contract for public works," approved June 26, 1941, as amended, being Illinois Compiled Statutes Chapter 820 ILCS 130/1-12, and;

WHEREAS, the aforesaid Act requires that the Township of Fremont of Lake County investigate and ascertain the prevailingly rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of said Fremont Township employed in performing construction of public works, for said Fremont Township.

NOW THEREFORE, BE IT ORDAINED BY SUPERVISOR O'KELLY AND THE BOARD OF TRUSTEES OF FREMONT TOWNSHIP, LAKE COUNTY:

SECTION 1

To the extent and as required by "An Act regulating wages of laborers, mechanics and other workers employed in any public works by State, county, city or any public body or any political subdivision or by any one under contract for pubic works," approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for laborers, mechanics and other workers engaged in construction of public works coming under the jurisdiction of the Township of Fremont is hereby ascertained to be the same as the prevailing rate of wages for construction work in the Lake County area as determined by the Department of Labor of the State of Illinois as of June of the current year a copy of that determination being attached hereto and incorporated herein by reference. As required by said Act, any and all revisions of the prevailing rate of wages by the Department of Labor of the State of Illinois shall supersede the Department's June determination and apply to any and all public works construction undertaken by the Township of Fremont. The definition of any terms appearing in this Ordinance which are also used in aforesaid Act shall be the same as in said Act.

SECTION 2

Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of the Township of Fremont to the extent required by the aforesaid Act.

SECTION 3

The Fremont Township Clerk shall publicly post or keep available for inspection by any interested party in the main office of Fremont Township this determination or any revisions of such prevailing rate of wage. A copy of this determination or of the current revised determination of prevailing rate of wages then in effect shall be attached to all contract specifications.

SECTION 4

The Fremont Township Clerk shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

SECTION 5

The Fremont Township Clerk shall promptly file a certified copy of this Ordinance with both the Secretary of State Index Division and the Illinois Department of Labor.

SECTION 6

The Fremont Township Clerk shall cause to be published in a newspaper of general circulation within the area a copy of this Ordinance, and such publication shall constitute notice that the determination is effective and that this is the determination of this public body.

2018 ROAD DISTRICT PREVAILING WAGE ORDINANCE NO. 271

WHEREAS, the State of Illinois has enacted "An Act regulating wages of laborers, mechanics and other workers employed in any public works by the State, county, city or any public body or any political subdivision or by any one under contract for public works," approved June 26, 1941, as amended, being Illinois Compiled Statutes Chapter 820 ILCS 130/1-12, and;

WHEREAS, the aforesaid Act requires that the Fremont Township Road District of Lake County investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of said Fremont Township Road District employed in performing construction of public works, for said Fremont Township Road District.

NOW THEREFORE, BE IT ORDAINED BY HIGHWAY COMMISSIONER WILLIAM D. GRINNELL AND THE BOARD OF TRUSTEES OF FREMONT TOWNSHIP, LAKE COUNTY:

SECTION 1

To the extent and as required by "An Act regulating wages of laborers, mechanics and other workers employed in any public works by State, county, city or any public body or any political subdivision or by any one under contract for pubic works," approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for laborers, mechanics and other workers engaged in construction of public works coming under the jurisdiction of the Fremont Township Road District is hereby ascertained to be the same as the prevailing rate of wages for construction work in the Lake County area as determined by the Department of Labor of the State of Illinois as of June of the current year a copy of that determination being attached hereto and incorporated herein by reference. As required by said Act, any and all revisions of the prevailing rate of wages by the Department of Labor of the State of Illinois shall supersede the Department's June determination and apply to any and all public works construction undertaken by the Fremont Township Road District. The definition of any terms appearing in this Ordinance which are also used in aforesaid Act shall be the same as in said Act.

SECTION 2

Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of the Fremont Township Road District to the extent required by the aforesaid Act.

SECTION 3

The Fremont Township Clerk shall publicly post or keep available for inspection by any interested party in the main office of Fremont Township this determination or any revisions of such prevailing rate of wage. A copy of this determination or of the current revised determination of prevailing rate of wages then in effect shall be attached to all contract specifications.

SECTION 4

The Fremont Township Clerk shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

The Fremont Township Clerk shall promptly file a certified copy of this Ordinance with both the Secretary of State Index Division and the Illinois Department of Labor.
