- Fremont CERT participated in a multi-team emergency simulation drill on October 13 at Wauconda Fire
  House #3. Seventy CERT members from five local CERTS divided into action teams to triage and treat the
  victims of a small plane crash. Team members felt the drill went well and provided valuable learning
  experiences.
- Team participated in the Countryside Fire and Grayslake Fire Department open houses in October
- At the October 15 Quarterly Meeting, Supervisor O'Kelly was the guest speaker and updated the team on Township services and activities.
- A well-attended outreach event at the Fremont Public Library covered emergency search and rescue procedures.

Clerk McCann reported the following:

Lake County Clerk's Office notification that 1040 Anna Lane, LLC has filed an objection against the town
fund for an illegal tax by a taxing body in relation to property they claim to own in Fremont Township.
Assessor Herchenbach will research the matter and, if required the township will consult legal counsel.

### **Highway Commissioner**

Commissioner Grinnell reported the following:

- Highway crews responded to four snow and/or ice events in November
- New technology installed in department trucks is doing a good job of monitoring how much salt is needed and spread during events. When possible, crews will apply beet juice in place of chemical salts.

Owens Road culvert and drainage work is primarily completed. Final work will commence in the spring Supervisor

Supervisor O'Kelly reported the following:

- Ninety-nine township families received Thanksgiving dinners via the Food Pantry donation program
- Received a large diaper donation from a local company
- Received four large boxes of toothpaste for food pantry distribution
- Received food donations from the Lake County Stallions food drive

- Attended Paratransit Lake County central meeting (Vernon Hills plans to join)
- Attended Public Aid Committee hearing for a Libertyville Township General Assistance Appeal case
