User Group Meeting Minutes

1. **Call to Order:** Meeting was called to order @ 1:00 by Dan Prezell
2. **Roll Call:** Trustee Shanahan, Dan Prezell, Alicia Dodd, Diana O’Kelly and Herb Riedel
3. **Public Comments:** None
4. **Approve the minutes of the Jan. 9th, 2019 Parks Meeting.** O’Kelly motioned and Shanahan seconded.
5. **Correspondence:** None
6. **Old Business:**
 - a. **Ballfield Light repairs @ Ivanhoe:** Riedel reported to the committee that Hwy Dept crews repaired (5) lights at Ivanhoe ballfield for a total cost of \$3503.64. This price includes the cost for new Fuse blocks, Fuses, Bulbs, Disconnect cords, plywood and machine rental. All lights currently working at Ivanhoe now.
 - b. **2019 Native Area additions:** “No Mow” fescue areas are coming in well, a “Native Meadow” area was established on the septic field area and all detention areas were control burned by parks staff. Dodd stated that Parks will possibly experiment with some additional areas this year once we see how newly seeded areas take.
 - c. **Pickleball Court repair (Spring 2019):** All cracks were sealed by Parks staff and are now just waiting for suitable weather to repaint damaged areas.
7. **New Business:**

- a. **Behm Park Paving of Walking Paths Bid Date:** Riedel stated that the bid date was April 23rd and it was decided to combine walking paths with Admin parking lots to try and get a better price.
 - b. **Crack Sealing of Behm Park & Ivanhoe Park Parking Lots (June/July):** Fremont will use Behm Pavement Maintenance to fill cracks at both Parks facilities this summer. No start date has been decided yet.
 - c. **Ivanhoe Dugout dismantle & rebuild (Quote from Action Fence):** Riedel stated that the Ivanhoe dugout repairs were more than he felt comfortable doing in house. A quote from Action Fence was presented to the committee. It was agreed by the committee to proceed forward with this quote and bring to the Board for approval.
 - d. **Multi-Purpose sideline fencing (Quote from Action Fence):** Sideline fencing was a requirement by Fremont Township to make sure that players and spectators were protected while participating or observing a game. The quote from Action Fence presented the committee with (2) options and ultimately it was decided to only install fencing approx. 100' along each sideline instead of the entire length of the field. Quote will go to the board for approval
 - e. **Security Camera system(s) for Behm:** A quote for (2) security camera systems was presented to the committee. A system to monitor the maintenance buildings and another system to be mounted to the restroom to observe park activities. Quotes will go to board for approval
