- Commissioner Dodd stated changes to her budget include incorporating Ivanhoe's SSA funds for road work they will complete this year. State law requires the road district pay project vendors direct and then submit for reimbursement from the County. A line item has been added for a potential loan from Town if tax revenues do not meet anticipated receipts for operations. Funds have also been allocated for the Sylvan Lake Dam including insurance and maintenance.
