

TAX LEVY ORDINANCE

FREMONT TOWNSHIP

ORDINANCE NO. _____

An ordinance levying taxes for all town purposes for **Fremont Township**, Lake County, Illinois, for the tax year 2022, collectable in 2023.

BE IT ORDAINED by the Board of Trustees of Fremont Township, Lake County, Illinois as follows:

SECTION 1: That the sum of **One Million Two Hundred Seventy Five Thousand Four Hundred Twenty Four Dollars (\$1,275,424.00)** are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

for the year 2022.
