Road & Bridge Fund

Most of the line items remain the same with some fund allocations being moved to accommodate increased expenses in certain areas. Funds have been carried over from previous years to complete outstanding road/drainage projects that have been delayed due to permitting issues. The Commissioner anticipates those projects will be completed this year.
