## ORDINANCE NO. 298

An ordinance levying taxes for all town purposes for **Fremont Township**, Lake County, Illinois, for the tax year 2024, collectable in 2025.

BE IT ORDAINED by the Board of Trustees of Fremont Township, Lake County, Illinois as follows:

**SECTION 1:** That the sum **of One Million Four Hundred Seventeen Thousand Nine Hundred Sixty Dollars (\$1,417,960.00)** are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:
