TAX LEVY ORDINANCE

FREMONT TOWNSHIP

ORDINANCE NO. 301

An ordinance levying taxes for all town purposes for **Fremont Township**, Lake County, Illinois, for the tax year 2025, collectable in 2026.

BE IT ORDAINED by the Board of Trustees of Fremont Township, Lake County, Illinois as follows:

SECTION 1: That the sum of **One Million Five Hundred Thousand and 0/100 Dollars (\$1,500,000.00)** are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:


SECTION 5: That this Ordinance shall be in full force and effect after its adoption, as provided by law.


I, the undersigned, hereby certify that I am the presiding officer of Fremont Township, and as such presiding officer I certify that the Levy Ordinance, a copy of which is attached hereto, was adopted pursuant to, and in all respects in compliance with the provisions of Sections 18-60 through 18-85 of the "TRUTH in TAXATION" law.
